

Complete Canine LLC. Liability release for day training, boarding and transporting

LIABILITY RELEASE, TRAINING AGREEMENT, and PET CARE AGREEMENT

- 1. I agree that I have hired Complete Canine LLC. Dog Training, as training professionals, to determine which tools are necessary to help me train my dog. I understand that I will obtain the best training results by following the instructions of the Complete Canine LLC. Dog Training trainer(s). I further understand that I am solely responsible for the training of my dog.
- 2. I certify that my dog is in good health, is free from fleas, ticks, heartworms, and all other parasites, and has received all required vaccinations, including: canine distemper, parvovirus, hepatitis, para-influenza, bordetella, and rabies. I agree that I am under a continuing obligation to report to Complete Canine LLC. Dog Training any signs of illness or infection in my dog.
- 3. In the event that my dog requires emergency veterinary treatment while attending a Board and Train program, Boarding, Day Training, or Daycare, I agree that Complete Canine LLC. Dog Training, in its sole discretion, will transport my dog to an appropriate veterinary facility for treatment and will immediately attempt to contact me. I assume all financial responsibility for veterinary treatment.
- 4. Complete Canine LLC. Dog Training strives to keep a clean and sanitary environment. I understand that even in cleanest environments, infections, diseases, and parasites may be transmitted between animals.
- 5. I understand and agree that if attending a Board and Train program, Boarding, Day Training, or Daycare, my dog may be placed in a kennel for periods of time during the day and/or night to allow for rest and downtime.
- 6. I understand that dogs are animals and even in the most controlled and well supervised environments, they may engage in inappropriate animal behavior. This includes, but is not limited to, rough playing, nipping, aggression, and dog bites. I further understand that although Complete Canine LLC. Dog Training staff closely monitors dog socialization and play to prevent injury, it is possible that my dog will receive minor nicks and scratches from other dogs. I agree with Complete Canine LLC. Dog Training they may use "corrections" to interrupt and/or stop my dog's inappropriate behavior.
- 7. In the event of cancellation I agree to notify Complete Canine LLC. 24 hours prior to the cancellation and if this is not accomplished I will pay in full for the missed session.
- 8. I have allowed Complete Canine LLC. to transport my dog for day training, boarding or daycare and understand that depending on the size of my dog they will be in crash tested equipment in the truck. Large dogs will be in the Gunner Kennel and small to medium dogs will be on harnesses and seat belts behind the driver seat.

Acknowledgement of Risk:

I understand that attendance and participation in Complete Canine LLC dog training, daycare, or

boarding is not without risk to myself, to my dog(s), and/or to third parties, and/or the dog(s) of third parties. The risks include, but are not limited to, the risk of property damage, personal injury from dog bites, scratches, or other injuries, death, infectious disease, and parasites. I agree that my dog's attendance and participation in Complete Canine LLC dog training, daycare, or boarding is voluntary and was undertaken with my knowledge of the known risks and other risks that may result from my dogs participation in training, boarding or daycare. I also understand that my dog will be transported for various training sessions to ensure better results. My dog will either be in a crash proof/ crash tested kennel or in a safety seat best in the back seat. I give consent for these travels and if anything were to happen I would not hold Complete Canine LLC. Dog Training or any of the staff accountable as I understand the risks.

Assumption of Risk:

I agree that I have been informed of the risks associated with dog training and have assumed the risk of my dog's attendance and participation in Complete Canine LLC. Dog Training , daycare, or boarding.

Release of Liability:

In consideration for my dog's attendance and participation in Complete Canine LLC dog training, daycare, or boarding, I fully release Complete Canine LLC. Dog Training from any and all claims and/or liability arising out of my dog's attendance at, or participation in, dog training, daycare, or boarding, including all claims for personal injury, wrongful death, and property damage. I agree to defend, indemnify, and hold harmless Complete Canine LLC. Dog Training from any and all claims and costs, including attorney's fees, arising out of or relating to my dog's attendance at, or participation in, Complete Canine LLC. Dog Training, daycare, or boarding, including claims of negligence against Complete Canine LLC. Dog Training or its staff.
